PAGE 1 KNAUGHTY KNOTTY STALLION SERVICE CONTRACT

This Agreement is entered into on this ____ day of _____ 20__ by and between Penny Treeby Hudgens as represented by PTH Barrel Racing, LLC, herein called the "Stallion Owner" and _____ herein referred to as the "Mare Owner(s)" for the Mare (as shown on the Registration Papers) AQHA Name & No. _____ APHA Name & No. _____ Other Breed & Registration # _____ Year Foal _____

These Parties Agree as follows: Mare Owner confirms a Reservation for the Mare described above to be serviced by the Stallion KNAUGHTY KNOTTY, AQHA #5179930 standing at the PTH Barrel Racing Farm during the Breeding Season of 2021 which begins February 1 and ends July 1, 2021.

1. A Stallion Fee charged the Mare Owner shall be eight hundred fifty dollars (\$850.00) which includes a two hundred (\$250.00) Booking Fee. The Booking Fee of \$250.00 is non –refundable and is payable upon execution of this Contract. Payment of the balance of the Stallion Fee is due seven (7) days before the semen will be collected.
2. Stallion Owner agrees to diligently try to settle aforementioned mare in season listed above. It is agreed that should the Mare Owner stop any future semen collection and shipment before the Stallion Owner has ample opportunity to settle said mare, then all unpaid expenses and balance of the 2021 Breeding Fee becomes due and payable.
3. Should the above named Stallion or Mare die or become unfit for service/breeding prior to first shipment of the cooled semen, then this Contract and Cooled Semen Transport Addendum (Page 2&3) shall become null and void and all monies paid as a part of this Contract shall be refunded.
4. Stallion Owner or any of their Representatives may exercise their own judgement in the care for and supervising the mare and/or foal but will not be held responsible for any accident, sickness or death of either the mare or foal.
5. Stallion Owner’s Veterinarian may check the mare for breeding condition or perform any Veterinarian Services as Stallion Owner deems necessary for treatment or protection of mare and/or foal at side at the Mare Owner’s expense.
6. Stallion Owner guarantees a Live Foal and that if the newborn foal does not stand and nurse without assistance, the Mare Owner will be entitled to a return breeding during the mare’s foaling year (same mare) and on the terms and conditions provided in this agreement. This is to be evidenced by a written form from a Licensed Veterinarian within 72 hours of the foal’s death.
 - A. If the Mare proves not to be in foal in the year bred, or loses her foal as stated Paragraphs 2 and 6, the Stallion Owner offers a rebreed to the same mare for the following season with the charge of the booking fee.
 - B. In the event the mare is sold or otherwise disposed of prior to the completion of this Contract, the Live Foal Guarantee is no longer valid.
7. This Contract is not assignable or transferable without written agreement of the Authorized Representative of PTH Barrel Racing, LLC and/or Penny Treeby-Hudgens.
8. The Cooled Semen Transportation Addendum (PAGES 2 & 3) will have precedence over this contract if applicable.
9. Exceptions to this Contract as mutually agreed to. (If you are requesting mare care, please specify here☺)

PAGE 3 KNAUGHTY KNOTTY STALLION SERVICE CONTRACT ADDEDUM

- 1. The Mare Owner as stated on Page 1 shall give the Stallion Owner as much advanced notice of request for semen shipment as possible (minimum of two 2 days) and the final request must be received by telephone (not an e-mail) from the Mare Owner or by the attending Veterinarian; no later than 9:00 AM (Central Standard or Daylight Time) on the day of Shipment. You will need to correlate shipping with the Stallion Owner or designated handler during and/or throughout the breeding schedule. The Stallion Owner's Veterinarian will be providing the Collection & Shipping Service, and both parties shall be notified as indicated.
- 2. The Stallion Service Fee includes a Booking Fee or \$250.00 payable upon the execution of this Contract as specified on Page 1. The balance of the 2021 Stallion Fee of \$600.00 must be paid in full before semen shipment is ordered.
- 3. A Shipping Fee of \$250.00 will be paid in advance of each Cooled Semen Transportation Shipment. This cost represents stallion collection, disposable container, lab/semen processing fees associated with shipped semen and normal Monday through Friday FedEx or UPS container shipping charges. Mare owners will be billed for additional charges such as unscheduled collection, courier service, weekend FedEx or UPS or Air Fight Transportation.
- 4. The Mare Owner is responsible for returning a report back to the Stallion Owner on the days the mare was inseminated and notify the Stallion Owner of the mare's pregnancy status within 20 days of last insemination.
 - A. If the Mare proves not to be in foal in the year bred or loses her foal as stated on Page 1, Sections 2 & 6, the Stallion Owner offers a rebreeding for the same mare the following season with the charge of a booking fee.
 - B. In the Event the mare is sold or otherwise disposed of prior to completion of this Contract, the Live Foal Guarantee is no longer valid.
- 5. The Mare Owner assumes responsibility for Association Documents, Registration Fees, Permits and DNA Typing pertaining to his/her mare and resulting foal.
